Surface preparation	 Brush or vacuum floor to remove all loose dirt and dust. For very dirty or contaminated surfaces clean with SPACENETT®* first.
Application tools	Microfiber flat floor mop. Lint free cloth.
Good application practice	 Apply at an ambient air temperature of between 10°C and 25°C. Prior to treating the whole area, test POLISHFLOOR® in a discreet area first to determine final finish and look. During application, we advise the wearing of rubber gloves and ensuring the room is well ventilated.

First application: Use undiluted.

Periodic maintenance applications: Dilute 2% POLISHFLOOR® in water.

Application	 Shake product well. First application: Apply a thin, even application of undiluted POLISHFLOOR®. Allow to dry. For a glossier finish repeat the procedure after the 1st application is dry. Allow surface to dry at least 8-12 hours before walking on. Periodic maintenance: Apply a thin, even application of diluted POLISHFLOOR®. Allow to dry. For a glossier finish repeat the procedure after the 1st application is dry. Allow surface to dry at least 1 hour before walking on.
Coverage	40 m² per litre. Coverage may vary depending on the condition of the floor and how dirty it is.
Maintenance	How often POLISHFLOOR® requires maintenance depends on the level of foot traffic (normal to severe).
Restrictions	Newly varnished and oiled surfaces must be left a minimum of 15 days before being treated with $POLISHFLOOR^{\scriptsize \circledR}$ for the first time.
Clean-up	Water.
Storage	Store away from frost and high temperatures.
