Application	<p>BRUSH, ROLLER, SPRAY Apply a liberal saturating coat to all exposed cut, bored and notched ends. Wipe off any drips or runs. Allow to dry.</p> <p>DIPPING Soak wood for 5 minutes. Drain off excess PCD 91. Allow to dry. PCD 91 is a preservative. It does not replace a finish. After the 48 hours drying time, pressure treated wood should be finished with SEASONITE®* or another OWATROL product suitable for new timber to reduce the effects of weathering – greying, splitting, warping etc as a result of sudden exposure to sun and rain. PCD 91 is compatible with any single or 2 pack finish.</p>
Coverage	<p>5-7 m²/L. Actual coverage will vary depending on application method, type, texture, age and porosity of the wood.</p>
Clean-up	<p>Water.</p>
Storage	<p>Keep from freezing and high temperatures. Store in original container.</p>
